- **GMOs and new genomic techniques:** in HU this is a very sensitive issue. The new HU Constitution contains now a rejection of GMOs. For this reason HU remains vigilant that the EU approach does not deviate from the ECJ decision on new genomic techniques (NGT) when it comes to the application of the GM legislation.
