Thank you very much for your invitation to the above mentioned working group, and for your interest in our work. Please note that it will not be possible to discuss the legal status of specific new breeding techniques, as you suggest in your mail. Even if the ongoing court case concerning certain new techniques is published by the date of our meeting, we would first need to assess the outcome and then share the Commission's next steps with all stakeholders, including Member States.

We would therefore suggest concentrating the discussion on your members' views on the specific traits being researched & developed (using new breeding techniques) in the EU (and around the world), and in which ways they can improve resource efficiency or offer other particular advantages. We would be interested to know whether there is a broad interest of EU farmers to cultivate crops developed using new breeding techniques, and what possible risks and issues they expect.

Of course, we are happy to listen and take note of your views on the legal status and their underlying explanation but you will understand that we will not be able to comment those.

If our suggested approach is acceptable to you and your members, my Unit would be pleased to be available on 14 May at 15 : 00.

As you kindly asked about presence of DG GROW, this is to inform you that we might stay for the following exchange of views with [REDACTED] & [REDACTED] at 16:00 (also in copy of this mail) . In other words, it is appropriate to have two separate exchange of views.
