1. Reference is made to your oral request as to the possible use of the above individual, either in connection with BLUEBIRD Project or elsewhere in CIA, upon his retirement from the ~~\_\_\_\_\_~~ in November, 1951.

2. As previously stated, I do not believe that ~~\_\_\_\_\_~~ is suitable, in view of his position and seniority, for recruitment in connection with one of the BLUEBIRD field teams. At the present time, The BLUEBIRD Project does not require a full time senior ~~\_\_\_\_\_~~ headquarters officer.

3. I discussed this matter with ~~\_\_\_\_\_~~ Deputy Chief, I & SS, who advised that at present I & SS has no position where ~~\_\_\_\_\_~~ services could be adequately utilized. I also talked with ~~\_\_\_\_\_~~ Assistant Director/Scientific Intelligence, A who stated that, while he had no available opening in connection with the BLUEBIRD Project, he would like to consider the possibility of using ~~\_\_\_\_\_~~ in the Medical Division of OSI. ~~\_\_\_\_\_~~ stated that as soon as he has had a chance to consider this, he will advise you of his interest, if any, in ~~\_\_\_\_\_~~.

1. Reference is made to the attached memorandum dated 23 July 1951 from the Chief, Special Security Division, concerning the above subject, and to your request that it be reviewed and you be advised whether or not an effort should be made to recruit [redacted] for the BLUEBIRD Project. B/6

2. The investigation conducted by Security does not reflect that [redacted] has unique qualifications for the BLUEBIRD Project. One factor developed by the investigation - namely, his [redacted] birth - is of some concern inasmuch as foreign birth would make it difficult for him to receive certain special clearances which might well become necessary if he were to function effectively in connection with the BLUEBIRD Project.

Recommendation: It is recommended that [redacted] not be recruited for BLUEBIRD at this time, unless on the basis of your personal knowledge of him you consider that he is uniquely qualified or particularly suited for this work. In the event you do consider him so qualified, it is suggested that he be contacted in order to ascertain whether or not he is interested in accepting employment with the agency. If he is interested, application forms should be procured from him, a full security investigation conducted, and the final decision as to his employment for BLUEBIRD made on the basis of the full investigation. B/6
