1. The following quotation is from [redacted] letter of 23 September 1954, addressed to me:

"I have a supply of [redacted] and the solvent and I am perfectly willing to give you some. There is not much as yet that has been printed on the subject. If you obtained a copy of the paper I read in [redacted] you have the most complete material written on the subject. I am the only one who has used this drug clinically. I will give a demonstration of its use [redacted] at one of the hospitals. If anyone of your principals would be interested in attending, I can make certain that room is made for him.

"I am sending you two bottles each containing one gram of [redacted] in suspension and two ampules of [redacted] which is the solvent. There is usually [redacted] in the ampule that it is not necessary to use to obtain a clear solution. The material does not stay in solution indefinitely--maybe three hours or a little more. It has to be made fresh. I have given it intravenously in suspension and intramuscularly in suspension. As of today, we have administered it to 185 persons. We have had three cases with temporary phlebitis where the drug was given; otherwise we have had had no untoward results."

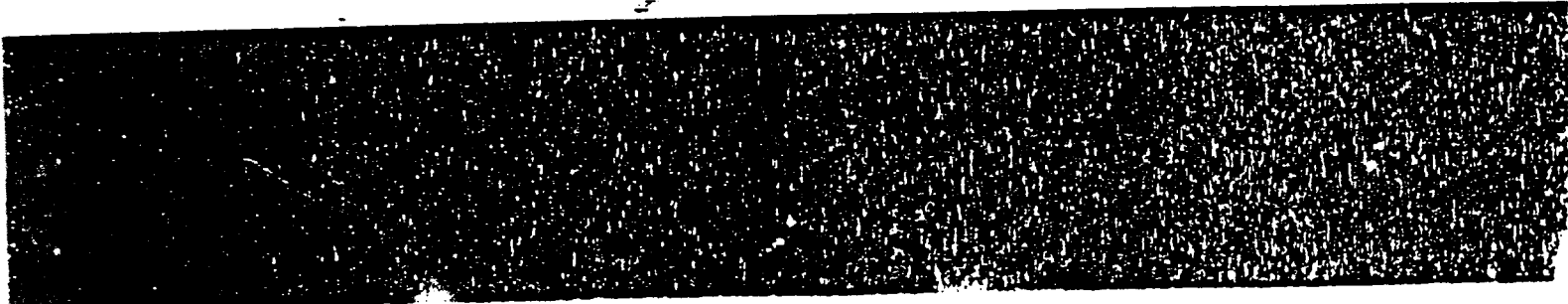
2. I picked up the letter and a supply of [redacted] [redacted]'s office yesterday; both were then in the process of being mailed. I was also able to spend some time personally with [redacted]

3. [redacted] is really serious in extending the invitation referred to in paragraph one of the above quotation. At the meeting on [redacted] will demonstrate the use of [redacted]. However, during the morning of [redacted] will give a talk on [redacted] at a "Hush Hush Meeting" to be held at the [redacted]. This meeting is by invitation. [redacted] had suggested that we have a representative or two present at this meeting and that he, himself, could

make arrangements for their attendance. He stated that these plans should be made during the late afternoon of [redacted] at the [redacted] where [redacted] will be staying. [redacted] is most cooperative and will work hand-in-hand with us so that there will be no disclosure of the attendance of our representatives.

4. As you probably know [redacted] is the only man that is conducting the investigation of the use of [redacted]

5. Commencing 1 October 1954 [redacted] is going to experiment with [redacted] and their findings will of course be disclosed later on.

[redacted] informed me that he has many new findings to add to the paper that he presented [redacted] (Copy of this paper was submitted to you under [redacted] Since the publication of the referred to paper in [redacted] received numerous inquiries from medical personnel throughout Europe and South American countries (None from "Behind-the-Iron-Curtain" Countries). A copy of letter used by [redacted] for replying to these inquiries is enclosed herewith.
