After awakening the subjects with the usual 12345 method and after some discussion, the writer tapped on the arm of his chair three times with a pen-cil and the second papeared to go to sleep. Each subject tried this experiment individually with the other subject as an observer. Both were returned to the awake state by the usual 12345 method.
