MEMORANDUM FOR: THE RECORD

SUBJECT : Supplementary Funds, MKULTRA, Subproject 65

1. The purpose of the supplement to this project is to support a special study predicting the adjustment of the refugees already examined in this project. Several members of the project staff will independently rate each subject on a specified list of adjustment variables having to do with health, occupation, social relationships, and acculturation.


2. While it has been anticipated that the original budget for the current year would cover the cost of this phase, delays in acquiring and processing the original data consumed the budgeted worktime of several of the staff members. The attached supplementary budget includes only salary payments to staff members who are no longer on the project payroll.

1. The purpose of this project is to continue Agency support of Dr. [redacted]'s studies on [redacted] refugees. At the present time the first phase of this study is approaching completion. It is expected that the second phase, that of predicting certain results of the displacement of these individuals, will occupy Dr. [redacted]'s facility for the remainder of this year. The third, or follow-up phase on these predictions, will be made by investigators other than Dr. [redacted].

2. This project was reviewed and approved by the Board of Directors of [redacted] at the meeting of 11 March 1957. It will be noted that the attached budget indicates an expenditure of \$87,621.00 for the coming year. Dr. [redacted] has agreed to obtain support from sources outside the Government to defray those costs exceeding \$50,000.00.

3. The cost of the program for a period of one year 1 July 1957 is estimated to be \$50,000.00. The [redacted] will be used as a cutout for transferring the money to [redacted]. Charges should be made against Allotment 8-2502-10-001.

Dr. [REDACTED]'s Project - Plans for the Coming Year, July 1957 - June 1958

We will have completed the interviewing of our [REDACTED] informants by July 1, 1957. In the course of six months we have examined and interviewed 70 informants - a task which required almost 1 1/2 years in the [REDACTED] study. The improved efficiency of the [REDACTED] study is in part the result of the experience gained with the investigation of the [REDACTED]. The rapidity with which the interviewing has been conducted has left us with a large backlog of material which is still to be transcribed and typed. Our present staff of typists will be busy for at least another six months in completing this work and our consumption of clerical supplies will remain high during this time.

With the completion of the [REDACTED] interviewing, the interpreters and some of the other special personnel who were hired specifically for this project will be dropped from the payroll. However, the task of digesting and collating the information and preparing the necessary reports is just beginning and will certainly occupy us for at least six months. Although our [REDACTED] speaking psychologist and our [REDACTED] anthropologist will not be giving nearly so much time to the project as they have during the past few months, it will nevertheless be necessary for them to participate in the evaluation of our information, and we will have to recompense them to some extent for their time. Our experience with the [REDACTED] and [REDACTED] leaves us with an extraordinarily large body of intensive information on a significant number of important representatives of these two societies. Although the first report on the [REDACTED] is now being completed, we have only begun to draw from these data much of the valuable information which can be obtained. It is my opinion that it is of great importance for the members of my staff to busy themselves during the next six months with the evaluation of the information which they have obtained and the completion of the reports based upon it.

During the same period, we will be engaged in planning the next step in our investigations. Preliminary conferences relating to this are now under way. We anticipate that our efforts will again be in the direction of the evaluation of significant members of other societies now under Communist domination, or otherwise of interest, and that we shall also concern ourselves with the development of methods of evaluation and assessment. Our next project should get under way some time after the first of next year, and the details will have been worked out well in advance of this date. The accompanying budget is based upon a plan of activities as outlined above.

The present stage of Dr. [REDACTED]'s project in brain function will have been completed by January 1, 1958 and at that time Dr. [REDACTED] will be transferred to this project on a full-time basis to give his time to the collation and publication of material assembled from the [REDACTED] and [REDACTED] studies. Up until that time he will be working on this project on a part-time basis.

conduct of the research program of MKULTRA Subproject 48. Subproject 48 was set up to continue under TSS the research activity originated under CIA special project [redacted] H
The administrative aspects of this activity are to be carried on as MKULTRA Subproject 60. The research work commenced by Dr. [redacted] under Subproject 48 is to be continued as Subproject 65.

2. The scope of the program to be undertaken by Dr. [redacted] will encompass a detailed study of those factors which influence human behavior that could be used as a means of achieving intelligence objectives. The major effort of Dr. [redacted] C
[redacted] s program will be:

- (a) To better understand the factors which cause individuals to defect, commit treason or change loyalties.
- (b) To develop skills by which potential defectors can be detected.
- (c) To develop methods for increasing the chances of defection of various target individuals.

A more detailed outline of the proposed program is attached.

3. Subproject 48 will expire on 30 June 1956. The [redacted] B
[redacted] estimates that there will be approximately \$74,000.00 of unexpended funds remaining. These funds were obligated in Fiscal Year 1956. - (b) Define the circumstances under which men have defected from military, political, religious, social and cultural groups and evaluate the factors appearing to influence such defections.
- (c) Study individuals who have maintained loyalty in the face of persistent, sustained attempts to change, affect and alter this loyalty and evaluate the factors appearing to contribute to this resistance.

"Defection" is defined as the conscious breach of allegiance or duty to a value system, cause, person, ideology, philosophy or organization, replaced by a willingness to actively support systems, etc., which are antagonistic to the position previously held.

To "systematically study" refers to (a) the asserbling and evaluating as much as possible of the pertinent information on the subject of defection viewed as an historical, sociological and psychological phenomenon; (b) examining a sample of known defectors and known resisters according to predetermined methods (medical, psychiatric, sociological and psychological); (c) systematically and objectively recording the results of such examinations; and (d) collating and evaluating the data obtained in order to determine significant differences, isolate important characteristics and test comparative methods for determining these differences and characteristics.

3. Status: A working group, primarily composed of professionals formerly engaged in the "Brainwashing" and "Chinese Cultural" studies has been formed. Much of the material already collected in these studies has applicability to the proposed study outlined above. This group has prepared a plan of action and they are ready to begin operation whenever requested. A major part of the study can be completed in one year.
